## TUITION RESPONSIBILITIES:

As with all education-based programs, tuition payments for **LSEVT** are the responsibility of the applicant. The full tuition fee for this program is **\$1100**. **Payment in full** must be received no later than **August 19th**. Requests for refunds must be in writing and received no later than **September 9, 2026**. **A \$25 fee will be charged for any payment not received by September 13, 2026**. An early tuition rate of \$995 will be given if paid by **July 31, 2026**. Tuition fees include all sessions and meals. ## TUITION ASSISTANCE:

Financial support is encouraged through sponsorships (e.g. through employers or organizations in which you are active). **LSEVT** may make scholarships available on an 'as-needed' basis. ## LEADERSHIP SOUTHEAST VERMONT ATTENDANCE POLICY

Leadership Southeast Vermont is a unique learning experience developed specifically for our region. Monthly seminars and case projects are the essential curriculum and means of teaching leadership skills. Through exposure, experience and interaction, leadership skills will be enhanced and developed.

Because of the commitment and responsibilities of all attendees, Leadership Southeast Vermont has the following attendance policy.

**It is expected and required that class participants will attend all 10 days of the Leadership Southeast Vermont over a 9-month period. Further, it is expected that all attendees will be prompt and refrain from outside interruptions as a courtesy to fellow participants and presenters. This is also the case with participation and attendance needed to complete the case project.**

If more than two days are missed during the year, or a participant fails to fairly and actively participate in the case projects, the Board will withhold the certificate without any refund of tuition. If the participant feels mitigating circumstances apply to their situation, the participant may appeal the decision to the Board. Participant will be allowed to “make-up” a missed seminar or participate in a project the following year on a fee basis, and then receive a certificate.

Both the applicant and employer will have to indicate they accept and agree to adhere to this attendance policy at the time of application and acceptance into the Leadership Southeast Vermont program.
